Jill made a motion to replace the pool chairs, and Terry seconded the motion. Terry and Pete will visit several places, match the color with the umbrellas, and get fabric that is durable, not the current plastic.

The Board is tabling the process to limit rental units in the community until they receive a report from the attorney regarding the procedure based on the community documents. The Board instructed the property manager to reach out to the attorney.

A rental spreadsheet will be created and kept up to date by Jill Gordon. Jill & Alex will manage/ attend any Zoom interviews needed for non-local rental applicants and attend local rental applicant interviews at the pool cabana.

The board approved the following topics:

- Repair and paint the property's front concrete wall.
- Consult with lawyers regarding dog park area.
- Property manager, Gloria, to provide a quote for increased property management services for Cumberland Trace POA, Inc. in preparation of Pete retiring as President.
- Obtain quotes for subterranean termite control for the community.

The board discussed making sure the trees are cut back from the buildings for Hurricane season.
